Re: *Zygor Guides, LLC*

This firm serves as counsel to Zygor Guides, LLC in connection with its intellectual property matters. Zygor Guides entered into a contractual agreement with the author of TourGuide on December 18, 2009 and has acquired and owns all rights to the TourGuide software. As you know, the TourGuide software enables users to guide themselves through World of Warcraft. The TourGuide software is an original and exclusive work owned by Zygor Guides and the source code, graphic and textual representations and artwork are protected by copyright as well.

Zygor Guides has learned that from December 18, 2009 until February 18, 2010, its TourGuide software has been copied or modified and that you were displaying, selling, or distributing copies of the TourGuide software, without authorization, on and through your website www.ultimatewowguide.com, which was a clear violation of Zygor Guides' copyright. The infringing software on your website included, but was not limited to, the following:

The ultimatewowguide.com website also includes screenshots of video clips, graphic and textual representations and artwork that embody the TourGuide

software. Zygor Guides has not authorized or licensed you to use, display, offer for sale, or reproduce the TourGuide software and these activities are not permitted by law without the express permission of the owner and, therefore, constitute copyright infringement. As you are aware, Zygor Guides has initiated DMCA takedown procedures with the Internet Service Provider, ThePlanet.com, who hosts your website. You have subsequently issued a counter-notification and in such notification you swore under penalty and perjury under the laws of the United States of America that you had the applicable rights to such material. This is a false and fraudulently sworn statement as you have not, and do not possess such rights.

This letter puts you on notice of Zygor Guides' intention to file a lawsuit against you for infringements that occurred from 12/18/09 through 2/18/10 and seek all remedies available to Zygor Guides. The Copyright laws of the United States, and other countries, provide for monetary penalties for the infringement of another's work, including damages up to \$150,000 per infringed work, attorney's fees and other costs.

To avoid the potential costs of defending your actions in court and in consideration for Zygor Guides foregoing litigation, you must submit a check made payable to Zygor Guides, LLC in the amount of \$75,000.00 USD to my attention at this office, or contact me directly to discuss a short term payment schedule. You must also immediately and forever delete from ultimatewowguide.com any and all software, screen shots, graphic and textual representations and artwork relating to the TourGuide software. Finally, you must further immediately and forever stop distributing and selling copies of the TourGuide software, or derivatives thereof, through ultimatewowguide.com or through or in connection with any other website, email address, business, or other manner.

If you immediately cease and desist from your infringement of the TourGuide software and pay the \$75,000.00 by March 31, 2010, Zygor Guides will agree to not bring a suit against you for these past infringements for so long as you now and forever cease any further use, development, modification, sale, or distribution of the TourGuide software. Note that \$75,000.00 USD represents only half of the \$150,000 damages recoverable under Copyright law.

We await your response and compliance with Zygor Guides' demands. If you do not comply in full by the aforementioned date, Zygor Guides will be forced to seek redress in a court of law.
